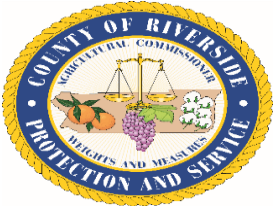

Summary of Manure Ordinance (427.3) Requirements

Exempt Operations:

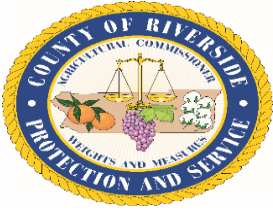
1. Applications conducted in association with recognized Ag program in a school.
2. Certain Ag sites associated with recognized Animal feeding Operations.
3. Active tree or vine farming operations.

Transporters:

1. No delivery without a copy of a valid and current exemption in possession.
2. No delivery without a copy of a delivery contract in possession.
3. No delivery without a copy of written permission from the landowner, if required.
4. No transport to a site within a ¼ mile of a public school in session.
5. Vehicles shall be designed to prevent spillage.
6. Vehicles shall be marked with Name and Address or Phone Number.
7. Vehicles shall have a current registration issued by the State of California.

Applicators:

1. No application of manure shall violate any conditions of this exemption.
2. No manure shall be applied within a ¼ of a public school when school is in session.
3. The site must have a valid and current exemption issued by the Riverside Agric. Commissioner's Office
4. The site must be at least 5 acres of tillable land, unless otherwise allowed.
5. The manure must be applied at agronomic rates.
6. The rate of application must be expressed in terms of tons/acre and depth of coverage in inches.
7. The time frame for planting the intended crop(s) must be clearly stated.
8. A copy of the permission and exemption must be available at the use site.
9. The exemption will be valid for up to 12 months. Any changes to the original exemption must be approved prior to application.
10. Manure shall not be applied within 100 feet of any well.
11. Manure must be spread evenly across the entire site.
12. Manure shall be incorporated continuously until complete to a depth of at least six inches, or as deep as practical, as follows:
 - a. Manure shall be fully incorporated before school is back in session when applied within ¼ mile of a public school.
 - b. Manure shall be fully incorporated within 48 hours when applied at sites less than 20 acres.
 - c. For sites 20 acres and greater, incorporation shall begin within 7 days of the 1st delivery, and shall be completed within 7 days of the final delivery, unless otherwise allowed.
13. Manure shall not be applied in windy conditions or inclement weather.
14. Manure must be applied in accordance with rates and schedules as indicated on the application, unless properly amended.
15. A notice of Intent to apply manure shall be submitted to the Agricultural Commissioner's Office and County Env. Health at least 48 hours in advance of the 1st delivery of manure, via phone or fax.
16. Prior violations shall be considered justification for denial of future exemptions applications.
17. All violations of the conditions in Ordinance 427.3 will be referred to the appropriate agencies for enforcement. Each day of a violation shall be considered a separate offense.

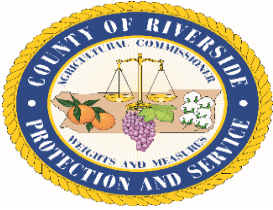

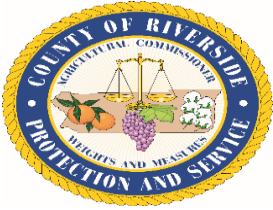
