## TO: PEST CONTROL ADVISERS WORKING WITHIN RIVERSIDE COUNTY

#### **REGISTRATION INSTRUCTIONS FOR 2024** (Office hours for registration are from 7:00 a.m. to 5:00 p.m.)

<u>PEST CONTROL ADVISERS:</u> Please complete and sign the registration form. The registration fee is \$10.00. **Make a check payable to** <u>County of Riverside</u>. Send the registration fee, the completed registration form and a copy of your 2024 PCA license to the Agricultural Commissioner's Office in Riverside. If you register in another county prior to registering in Riverside County, only send the validated application and a fee of \$5.00. *For your convenience, you can now pay online at www.rivcoawm.org.* 

**NOTE:** All PCA's requesting permits for growers will need to have a valid authorization form signed by the property operator for the 2024 season, as well as maps for all sites to be treated. Please **call in advance to** <u>schedule an appointment</u> (office hours for permit issuance are 8:00 a.m. to 3:00 p.m.).

If you have applied for a 2023 or year 2024 license and have not received your card, please contact the Department of Pesticide Regulation (DPR) prior to registering with Riverside County. <u>No registrations will be processed without a valid license.</u>

#### All mail must be sent to P.O. Box 1089, Riverside CA 92502-1089, or it will be returned.

### IF FEES ARE PAID ONLINE, REGISTRATION FORMS ARE STILL REQUIRED TO BE SUBMITTED TO OUR OFFICE. BEGINNING 2021/22, THE AGRICULTURAL COMMISSIONER'S OFFICE WILL NO LONGER BE MAILING COURTESY REGISTRATION FORMS.
