**TO: PEST CONTROL BUSINESSES WORKING WITHIN RIVERSIDE COUNTY**

**REGISTRATION INSTRUCTIONS FOR 2025  
(Office hours for Registration are from 7:00 AM to 5:00 PM)**

PEST CONTROL BUSINESSES: Please complete and sign both the registration form and the equipment registration form. The registration fee is \$60.00. Make a check payable to the County of Riverside. Send the registration fee, the completed forms, and a copy of your 2025 Agricultural Pest Control Business License to the Agricultural Commissioner's Office in Riverside. Note: for each branch office, a separate registration is required as well as an additional \$60.00 fee. The registration fee for *Maintenance Gardener Pest Control Businesses* is \$25.00. **For your convenience you can now pay online @ [www.rivcoawm.org](http://www.rivcoawm.org)**

Please note that we will no longer be accepting monthly summary pesticide use reports with both agricultural use and structural use on one form. Please submit 2 separate reports. **Pesticide use reports may be submitted electronically** instead of submitting paper copies; for further information, please contact one of our offices.

If you are also applying for a 2025 Restricted Materials Permit, please **call-in advance to schedule an appointment** (office hours for Permit issuance are from 8am to 3 pm).

If you have applied for a 2024 or year 2025 license card and have not received it, please contact the Department of Pesticide Regulation (DPR) prior to registering with Riverside County. **No registrations will be processed without a valid license and work may not be performed until registration occurs.**

**IF FEES ARE PAID ONLINE, REGISTRATION FORMS ARE STILL REQUIRED TO BE SUBMITTED TO OUR OFFICE.**
