REGISTRATION PROCEDURES FOR 2023**

STRUCTURAL PEST CONTROL OPERATORS: Please complete and sign the enclosed form, including the "BRANCH OFFICES" section and the license number sections and send with the fee of \$25.00 (make check payable to 'County of Riverside'). For your convenience you can now pay online @ www.rivcoawm.org. Please write the "branch license number" for each branch office in the space provided. An incomplete registration form may result in delaying the registration process. If you have applied for an Operator's License and have not received it, please contact the Structural Pest Control Board prior to registering in Riverside County. No registrations will be processed without a valid license and work may not be performed until registration occurs. We are no longer accepting monthly summary use reports with both agricultural use and structural use on one form. Please submit separate forms for both. Negative use reports do not require a structural stamp. **Pesticide use reports may be submitted electronically instead of submitting paper copies; for further information, please contact one of our offices.**

NOTE: A 24-hour Notice of Intent to apply MBr, Vikane, Zythor or Master Fume is required. This notice of intent should be reported by fax at (951) 955-3047, or in person. Please provide the following information: 1) Date and Time NOI is sent, 2) Company Name, 3) Business Phone Number, 4) Application Address and City, 5) Map Page and Grid Coordinates (i.e., 7 B2), 6) Date of Application Description of site to be treated, and 7) Pesticide Name -- MBr, Vikane, Zythor or Master Fume.

All mail must be sent to P.O. Box 1089, Riverside CA 92502-1089 or it will be returned.

**IF PAYMENT IS MADE ONLINE, REGISTRATION FORMS ARE STILL REQUIRED TO BE SUBMITTED TO OUR OFFICE.
